

PARTICIPANT TERMS AND CONDITIONS

THESE TERMS AND CONDITIONS INCLUDE A RELEASE OF CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE OR CLAIM COMPENSATION FOLLOWING AN ACCIDENT. PLEASE READ CAREFULLY.

These Terms and Conditions (“Terms”) govern your participation in Cloverdale Mall’s—Chillin’ with Santa—Santa’s Snowflake Celebration (“Event”) made available by QuadReal Property Group Limited Partnership (“QuadReal”, “we” or “us”).

1. Contractual Relationship

These Terms are a legally binding contract between you and QuadReal. By participating in the Event, you agree to be bound by these Terms. If you do not agree to these Terms, or cannot comply with these Terms, you may not participate in the Event.

These Terms will be exclusively governed by and construed in accordance with the laws of the Province of Ontario and the federal laws of Canada applicable therein.

2. Participation in the Event

Participation. For events where attendees are under the age of 18 a parent and/or guardian must register the minor and must remain in attendance at the event at all times. Registration and Payment. You must register for the Event through the online registration system designated by QuadReal and, if a participation fee and any related ticketing platform service charges are required (the “Participation Fee”), you must submit payment of the Participation Fee at the time of registration. If a Participation Fee is required, you will not be entitled to participate in the Event until full payment has been received by us. The Participation Fee is non-refundable unless the Event is cancelled by us for any reason, in which case we will refund the Participation Fee to you with no further liability whatsoever arising from such cancellation.
